

# Equine Biosecurity Protocol As of June 1, 2023

In our continued efforts to maintain a high level of safety, Tryon International Equestrian Center (TIEC) has the following biosecurity protocols designed to do our part to keep your horses safe, as well as those of your fellow competitors.

## Horses are NOT allowed to enter property if:

- The horse has been located in a United States Department of Agriculture (USDA) confirmed Vesicular Stomatitis (VS) Affected State.
- The horse has known symptoms of EHV or has been treated for EHV-1/4 within the past 28 days.
- Horse has been at a facility under quarantine for EHV-1/4/VS or any other infectious disease or exposed to any horses showing symptoms of infectious disease within the past 28 days.

## **Horses entering property MUST:**

- Have a current Coggins test within one year. Must present Coggins record upon arrivalpaper or electronic forms are accepted.
- Be vaccinated for Influenza at least 2 weeks and no more than 6 months prior to arrival.
- The state of North Carolina requires a current Health Certification for all horses, crossing into NC from other states.
- Horse has received regular and consistent vaccination against Equine Influenza and EHV-1/4 with the most recent booster being within 180 days (as per USEF GR 845).
- Current vaccination against WNV, EEE, WEE, Tetanus. Rabies vaccine is strongly recommended.

#### **Upon Arrival:**

- We strongly recommend all barns to check the temperature of all horses once they arrive at TIEC, prior to entering the barn. If a horse has a temperature of 101.5 or higher, TIEC management must be contacted immediately and the horse placed in an isolation stall, on-site to allow for time to recheck temperature prior to entering the barn.
- TIEC strongly requests that all barns on TIEC show grounds to maintain a temperature log with twice-daily temperatures recorded and require posting on each horse's stall door.
- Any horse on the show grounds with a fever of unknown origin or of suspicious origin
  must be reported to TIEC Management immediately. It is always better to err on the side
  of safety. Isolation stalls will either be available on the grounds or at a local veterinary
  practice if the need arises.



It is our shared responsibility to keep our horses safe. We urge all equestrians to please remember and abide by additional biosecurity measures.

#### Additional Recommendations:

- Take all horses' temperature daily and report any horse with a temperature above 101.5 degrees Fahrenheit or any signs of respiratory or neurological disease to your veterinarian and/or show management.
- Avoid mixing of horses where possible, practice equine 'social distancing'
- Please take the time to review equine good hygiene practices and impress its importance to your grooms and barn managers in everyday care
- Bring your own hoses to barns and do not share water buckets or fill from hoses used by other horses. Communal hoses will NOT be provided. Please bring your own.
- Every effort should be made to minimize stress and commingling of horses shipped long distances. Extra hours on a horse van or moving from stable to stable is the fastest way to compromise your horses' and your neighbor's horses' health.
- TIEC will practice additional biosecurity and disinfection protocols during our stall turnovers and around the facility on a daily basis.
